Non-profit business are exempt but may be called upon to prove their non-profit status. Garibaldi Ordinance 131 (enacted 3/10/86) requires all solicitors, peddlers and hawkers to have a City business license and be bonded. Complete all applicable information on both sides of this form. Business licenses are good from July 1, to June 30, every year. License fees are not pro-rated.
