

RESOLUTION 2016-13

**A RESOLUTION AUTHORIZING STAFF TO PURSUE AN ODOT SPECIAL CITY ALLOTMENT GRANT**

**WHEREAS**, under the provisions of ORS 366.800 and 366.805, there has been withdrawn from state highway funds appropriated for allocation to the several cities of the State of Oregon the sum of One Million and No/100 (\$1,000,000) Dollars, and in addition there has been withdrawn from monies available to the Department of Transportation from the State Highway Fund the sum of One Million and No/100 (\$500,000) Dollars. As provided in ORS 366.805, said sums have been set up in a separate account to be administrated by the Oregon Transportation Commission and to be allotted each year by said commission to be spent, within cities of 5,000 or fewer persons, upon streets not a part of the state highway system that are inadequate for the capacity they serve, or are in a condition detrimental to safety; and

**WHEREAS**, No one project can receive more than \$50,000; and

**WHEREAS**, The City of Garibaldi is an incorporated City of the State of Oregon and has a population of less than 5,000 as given by the latest official federal census; and

**WHEREAS**, 5<sup>th</sup> Street from Garibaldi Ave. to Cypress Ave. meets the conditions requires in ORS 366.805,

**NOW, THEREFORE, THE COMMON COUNCIL OF THE CITY OF GARIBALDI RESOLVES AS FOLLOWS:**

**Section 1.** That the aforementioned named street of the City of Garibaldi is inadequate is in need of reconstruction and improvement, and that this street is an important arterial connector for our community.

**Section 2.** That said streets are not a part of the state highway system, and are under the jurisdiction and control of the City.


**Section 3.** That the Oregon Transportation Commission is respectfully requested to consider and declare said street as qualified for reconstruction and improvement out of funds allocated and made available by and through the said \$1,000,000 appropriation of revenues which is to be administered and spent by the Transportation Commission.

**Section 4.** That the City of Garibaldi does hereby offer to the Transportation Commission and does hereby pledge complete cooperation and assistance to the end, that said City may share and participate in the use and benefit of said special fund and appropriation; and therefore does designate the City Manager as the official representative of the City in all negotiations resulting from this request.

**Section 5.** There is attached hereto and made a part hereof, a City map on which is indicated the street, streets, road, or roads, described in this resolution. This map is labeled "**Exhibit A**".

**Section 6.** There is attached hereto and made a part hereof, a completed ODOT SCA application form that council hereby authorizes the Mayor and City Manager to sign. This form is labeled "**Exhibit B**".


