

**RESOLUTION NO. 2008-02**

**A RESOLUTION AUTHORIZING APPROVAL OF AN UPDATE ADDING PROPOSED MITIGATION INITIATIVES TO MITIGATE THE CITY OF GARIBALDI HAZARD VULNERABILITIES TO THE GARIBALDI HAZARD MITIGATION PLAN, AN APPENDIX TO THE TILLAMOOK COUNTY MULTI-JURISDICTIONAL HAZARD MITIGATION PLAN**

**WHEREAS**, Garibaldi added initiatives to mitigate hazard vulnerabilities through the Garibaldi Hazard Mitigation Plan, an appendix to the Tillamook County Multi-Jurisdictional Hazard Mitigation Plan through Resolution 2005-20 on November 21, 2005; and

**WHEREAS**, the Garibaldi Hazard Mitigation Plan was adopted through Resolution 2004-15 on October 25, 2004; and

**WHEREAS**, the City Council established an Emergency Preparedness Committee (EPC) on July 18, 2005 to deal with these issues; and

**WHEREAS**, the City Council appointed the EPC to serve as the Hazard Mitigation Planning Committee and appointed the Chair of the EPC on October 17, 2005 to serve on the Tillamook County Hazard Mitigation Plan Steering Committee; and

**WHEREAS**, Garibaldi's main transmission line along the Miami River suffered severe erosion that exposed the line above the river's bank during the course of the last two storm events (Decembers 2006 and 2007); and

**WHEREAS**, this line is a critical facility and should be rerouted to avoid further damage that could jeopardize service to municipal users; and

**WHEREAS**, Garibaldi's Emergency Preparedness Committee has made an additional recommendation on January 15, 2008 to the City Council to amend the list of Implementation of Mitigation Measures to Reduce Hazard Vulnerability and an additional initiative that may be eligible for FEMA Pre-Disaster Grant Program monies; and


**WHEREAS**, the eligibility of these initiatives needs to be authorized through resolution by the Garibaldi City Council; NOW THEREFORE,

**THE COMMON COUNCIL OF THE CITY OF GARIBALDI RESOLVES AS FOLLOWS:**

**Section 1.** The City of Garibaldi approves an update identifying hazard vulnerabilities and adding a Mitigation Initiative to reduce those vulnerabilities to the City of Garibaldi Hazard Mitigation Plan, an appendix of the Tillamook County Multi-Jurisdictional Hazard Mitigation Plan.

**Section 2.** The City of Garibaldi approves Initiative 08-01 for Garibaldi Water Transmission Line Relocation.
