

**RESOLUTION 2011-14**

**A RESOLUTION ENTERING INTO AN INTERGOVERNMENTAL AGREEMENT (IGA) WITH CERTAIN FIRE SERVICE AGENCIES IN CLATSOP AND TILLAMOOK COUNTIES**

**WHEREAS**, Fire Service Agencies in Clatsop and Tillamook Counties recognize that fires and emergencies that occur within these counties have the potential of requiring resources exceeding what is available to these agencies individually; and

**WHEREAS**, the City of Garibaldi Fire Department desires to enter into an agreement that establishes and clarifies the operational policies and departmental requirements necessary for facilitating mutual assistance between these agencies; and

**WHEREAS**, this agreement will be entered into by numerous agencies and it is impractical to require minor changes to the text of the agreement to accommodate specific procedural and policy requirements of the City of Garibaldi and its Fire Department; and

**WHEREAS**, this agreement has been reviewed by the City Manager, the City Attorney and the Fire Chief, who have found the agreement to be generally acceptable; NOW, THEREFORE

**THE COMMON COUNCIL OF THE CITY OF GARIBALDI RESOLVES AS FOLLOWS:**

**Section 1.** The Mayor and City Manager are hereby authorized to sign the Clatsop and Tillamook Inter-County Mutual Aid and Emergency Assistance Agreement (IGA), which is attached as Exhibit A and incorporated by reference into this resolution, on behalf of the City of Garibaldi.

**Section 2.** The Fire Chief and City Manager are designated as the Contact Persons as described in this IGA.

**Section 3.** The Fire Chief shall coordinate with the City Manager or a designee prior to responding to, or making a request for, mutual aid under the terms of this IGA.


**Section 4.** The City of Garibaldi recognizes "Oregon Conflagration Act" as used in this IGA to mean the Oregon Emergency Conflagration Act.

**Section 5.** The City of Garibaldi understands Article XVII of the IGA to mean that this IGA will not supercede, replace, repeal or interfere with any other existing agreement for mutual aid or emergency assistance with any other party to this IGA.


**Section 6.** The City Manager of the City of Garibaldi shall send a copy of this resolution (as adopted and signed) to the other parties to the IGA.
