

ORDINANCE NO. 30

AN ORDINANCE FIXING SEWER CONNECTION RATES AND SEWER RATES AND CHARGES FOR THE USE OF SEWAGE FACILITIES IN THE CITY OF GARIBALDI, OREGON; PROVIDING FOR THE COLLECTION THEREOF AND THE DISPOSITION OF SUCH RATES AND CHARGES COLLECTED.

The people of Garibaldi City do ordain as follows:

Section 1. Garibaldi City does hereby establish the following connection charges and monthly rates and charges for the connection with and the use of sewage facilities of Garibaldi City in accordance with the schedule hereunto attached, marked Exhibit A and made a part hereof.

Section 2. The City Recorder of Garibaldi City is hereby directed to collect the rates and charges provided for in Section 1 of this ordinance from each user of the sewage facilities of said city. All charges shall be shown on a regular monthly statement prepared and posted by said city recorder; said charges as and when collected by said city Recorder shall be paid over to the Treasurer of the City of Garibaldi.

Section 3. The word "user" is defined to be the property owner or tenant and the property owner will be held responsible should any tenant not pay the said charges when due.

Section 4. When any vacant lot which may be served by the sewage facilities of the City of Garibaldi City is improved and when application is made for a sewer connection the owner of said property shall pay a sum equal to 50% of the sewer service charges that will apply to the new structure from the effective date of this ordinance to the date of the said application, but not for a longer period than 5 years. The sum paid as hereinbefore provided shall be deemed said applicant's share in applying the cost of disposal facilities that has been carried by other users.

Section 5. Garibaldi City may enforce the collection of rates and charges for the use of sewage facilities by any means that may be provided by the laws of the State of Oregon by certifying to the Tax Assessor of Tillamook County, Oregon, for collection in the manner and as provided by Section 2, Chapter 289, Oregon Laws, 1933 or permitted by the Charter and Ordinances of Garibaldi City.

Section 6. In the event it becomes necessary to certify the service charges hereby established because of the non-payment thereof there shall be added to such charges a penalty in the amount of ten (10%) per cent thereof and the same shall bear when certified interest at the rate of 8% per annum from the date of such certificate.

Section 7. The City Treasurer of Garibaldi City is hereby directed to set aside and pay into the SEWAGE DISPOSAL SYSTEM SINKING FUND heretofore created by Ordinance No. 31 of Garibaldi City, all of the gross revenue received from charges and rates collected for use of the sewer facilities as herein provided, however, that the said City Treasurer shall withhold \$100.00 each month from said funds to be expended for the administration and operation of said sewage disposal system.
