

ORDINANCE NO. 41

AN ORDINANCE DECLARING AN ASSESSMENT AGAINST REAL PROPERTY IN THE CITY OF GARIBALDI, DECLARING SAID ASSESSMENT TO BE A LIEN UPON SAID REAL PROPERTY AND DECLARING AN EMERGENCY.

THE CITY OF GARIBALDI DOES ORDAIN AS FOLLOWS:

Section 1

It is hereby declared that an assessment in the amount of Two Hundred Twenty-Five Dollars (\$225.00) shall be and hereby is assessed upon and against the following described real property:

Lots 5 and 6 in Block 7
Garibaldi Cove Addition to
Garibaldi, Tillamook County,
Oregon.

Section 2

Said assessment shall forthwith be entered in the Docket of City Liens of the City of Garibaldi and shall immediately thereupon become a lien upon and against the above described real property.

Section 3

The Recorder of the City of Garibaldi shall forthwith after docketing said assessment in the docket of City Liens, record this ordinance No. 41 in the Lien Docket in the records of the County Clerk of Tillamook County, Oregon.

Section 4

This assessment and lien is assessed and levied to secure the payment of the cost and expense of razing buildings and improvements upon the above described real property in accordance and compliance with the terms, conditions and provisions of Ordinance No. 40 of the City of Garibaldi, providing for the prevention and removal of dangerous buildings.

Section 5

EMERGENCY CLAUSE: Whereas the peace , health and safety of the people of the City of Garibaldi is involved, THEREFORE, an emergency is declared to exist and this ordinance shall be in full force and effect from and after its passage by the Common Council and approved of and by the Mayor.
