ORDINANCE NO. 56

AN ORDINANCE TO PROVIDE FOR THE NAMING OF CERTAIN UNNAMED STREETS, ALLEYS, LANES AND ACCESS ROADS USED BY THE PUBLIC, IN THE CITY OF GARIBALDI.

WHEREAS, the CITY OF GARIBALDI did by Ordinance No. 55, duly enacted on the 22nd day of August, 1960, adopt a uniform system of names designating the avenues and streets in the City of Garibaldi, and

WHEREAS, after said ordinance was duly adopted, it came to the attention of the Common Council of the City of Garibaldi that there are, within the city limits of said city, certain unidentified roads and alleys being used by the general public as passageways over property belonging to the city and property belonging to private parties, and

WHEREAS, it is deemed advisable to temporarily locate, describe and name these streets, lanes and alleys for the purpose of establishing uniformity in conjunction with Ordinance No. 55.

NOW THEREFORE, THE CITY OF GARIBALDI DOES ORDAIN AS FOLLOWS:

Section 1. All access roads and passageways not dedicated to the City of Garibaldi, and extending between, over or across property owned by more than one person, shall be presently known as and named LANES.

Section 2. All access roads and passageways not dedicated to the City of Garibaldi, and extending over or across property owned by one person only shall be known and named DRIVES.

Section 3. That certain road beginning at the intersection of Garibaldi Avenue and Driftwood Avenue and extending northeasterly over private property to the intersection with Evergreen Avenue shall be and is hereby named KEENON DRIVE; That certain road beginning at Garibaldi Avenue East and extending northeasterly over private property shall be and is hereby named NELSON DRIVE.

That certain road beginning at the corner of First Street and Cypress Avenue and extending Eastward from First Street to a deadend shall be and is hereby named CYPRESS LANE; That certain road beginning at First Street and extending Westward between Driftwood and Evergreen Avenues to a deadend be and the same is hereby named ELM LANE; That certain road beginning at Ninth Street and extending Eastward along a city alley between Birch Avenue and Cypress

Avenue shall be and is hereby named BEECH LANE: That certain road beginning at Twelfth Street near the intersection of the Southern Pacific Railroad right-of-way and extending westerly along said right-of-way to Fourteenth Street and Easterly along said right-of-way a short distance toward Eleventh Street, both of which are dead end roads shall be and is hereby named BAY LANE.
