

## ORDINANCE NO. 98

AN ORDINANCE AMENDING THE SOLID WASTE COLLECTION FRANCHISE ORDINANCE NO. 88, PROVIDING FOR NEW RATES, AND DECLARING AN EMERGENCY.

WHEREAS, the City Council of the City of Garibaldi held a public hearing on the proposed change of rates by George Reding doing business as R Sanitary Service on Monday, December 29, 1980; now, therefore,

THE CITY OF GARIBALDI ORDAINS AS FOLLOWS:

Ordinance No. 88 is amended to read as follows:

Section 7. Rates. The fee that the franchisee may charge for removal of solid waste or refuse shall be as follows:

MINIMUM MONTHLY RATES FOR ONCE A WEEK SERVICE

1 can	\$3.75	\$4.25
2 cans	\$7.00	\$8.00
Each additional can	\$3.25	\$3.75
Straight handling charge /can	\$2.00	\$2.25
25% additional charge for 1 flight of steps up or down or for entering a building.		

HOURLY HAULING RATES

Truck and 1 man	\$30.00 per hour
Truck and 2 men	\$47.50 per hour
Minimum charge	\$30.00

CHARGES FOR CONTAINER SERVICE

The operator shall retain ownership of the containers and shall make the following charges to the consumer. The charges shall be for the full capacity of each container furnished.

One 1 yd. container once a week	\$20.00
One 1 yd. container twice a week	\$41.00
One 1 yd. container three times a week	\$59.00
One 1 1/2 yd. container once a week	\$31.00
One 1 1/2 yd. container twice a week	\$55.00
One 1 1/2 yd. container three times a week	\$80.00
One 2 yd. container once a week	\$41.00
One 2 yd. container twice a week	\$76.00
One 2 yd. container three times a week	\$111.00

For the purposes of this ordinance, "can" is considered to be a container of not more than 30 gallons with a combined weight of contents and can not exceed 60 pounds. Franchisee shall not be required to service underground cans unless the property owner places the cans above ground.

The franchisee may pass through to the consumer the exact cost of the dump fee charge by Tillamook County Landfill. The franchisee shall not be required to pay a franchise fee on the amount collected for the dump fee.

The City of Garibaldi deems an emergency to exist and therefore this ordinance shall be in full force and effect upon the passage and signing by the Mayor.
